EMPLOYEES AND THEIR FAMILIES HAD ACCESS TO COUNSELING, CHILD CARE RESOURCES, AND OTHER SUPPORTS THAT HELP THEM REMAIN BOTH EMPLOYED AND STABLY HOUSED.
